Leo Buhlman, founder of the Eau Galle Cheese Factory, apprenticed for eight years as a cheese maker in Switzerland before coming to the United States in 1926. After working at a number of Wisconsin cheese factories and learning English, Leo purchased the then closed cheese plant in Eau Galle, Wisconsin in 1945. It became known as the Eau Galle Cheese Factory.

He made and marketed Swiss cheese for the next thirteen years. In 1958, he made and marketed cheddar cheese. Within a few more years, he began making hard Italian cheese, which to this day is Eau Galle Cheese Factory's niche.

In 1964, his son, John, took over management of the plant. Leo continued putting in long days making cheese until he was 89 years old.

In 1986, the Eau Galle Cheese Factory built a new state-of-the-art facility four miles east of Eau Galle on State Hwy 25, two miles north of Durand; but, it retained the name of the village where it all began.

In 2005, the factory underwent measures to improve its facility and added all new automated equipment. The plant was also certified in 2005 for production of organic hard Italian cheeses.

#### **SOCIETY NEWS**

More than 100 people attended the PCHS Autumn Education Event last October to hear Brian and Evan Gabriel talk about their experiences exploring the landscape and history of the Chippewa River between Caryville and Meridean. It was one of the largest audiences PCHS has had during the past few years

PCHS had another successful financial year during 2009. Expenditures totaled \$7,145, almost half of which was what the society paid for its summer intern in wages, income taxes, social security, unemployment insurance, etc. Revenues from memberships, memorials, donations, and sales of books and cards, etc. totaled \$4,505 and transfers from savings and certificates of deposit were \$3,152 for total revenues of \$7,657. PCHS held no major fundraisers during 2009.

At the year's end, the society's checking and savings accounts and CDs totaled \$27,175, which was \$1,353 less than where it finished in '08.

#### **MUSEUM NEWS & NOTES**

Changes continued at the Old Courthouse Museum as the staff created new displays and modified existing ones. Room Two has been partly re-designed to include a display celebrating music and musicians. Musical instruments, a bandstand and costume used by county residents are on exhibit. Also, new halogen lighting has been installed in Room One.

Recent acquisitions include a silver asbestos-lined fullbody firefighters suit and helmet donated by the Durand Volunteer Fire Department and a hand-written thank you note by Helen Parkhurst to Horace (Hank) Hougen donated by Greater Insurance Services.

An estimated 600 hours were donated by a couple dozen volunteers to operate the museum during 2009; plus, nearly 300 hours of paid staff time for the summer intern. Volunteers include our Saturday Hosts, a regular Tuesday work crew of four or five, and several other intermittent workers. We couldn't do it without our volunteers!!

**Gravestone Returned to Pepin County** 

Jeffrey and Peggy Watson of Minneapolis discovered this marker in the garage of their recently purchased home last Fall. With a little bit of historical investigation, they were able to track it to Pepin County.

The marker appears to be the gravestone of Miletus Knight, an important resident of Pepin County during the late 1800s-early 1900s. Miletus was a deputy sheriff for Pepin County in 1881 and figures prominently into the events leading up to the infamous shooting of the Coleman brothers by the Maxwell brothers in July of that year. He was also on duty at the time of Ed Maxwell's lynching in Durand on November 19, 1881.

Knight was a successful business man, farmer, postmaster in Arkansaw, and was County Clerk for one term. He also served one term as sergeant-at-arms of the Wisconsin assembly and two terms as transcribing clerk of the state senate.

#### LEGEND OF BATTLE ISLAND

[Battle Island is located in the Chippewa River in the east 1/2 of Section 15, T23N, R14W, about 4 miles upstream of the confluence of the Chippewa and Mississippi Rivers near the east side of the river (Buffalo County). The following was related to Jim Boettcher, a Wis. Dept. of Natural Resources Hydrologist, by Chauncey Weitz, a former Game Warden with the Wisconsin Conservation Department 1933-1966 and his son, David Weitz, Public Information Officer for Wisconsin DNR 1978 to 2007.]

"At the time of the battle Chippewa Indians living at Lac Courte Oreilles Reservation had to travel to Fort Snelling in Minnesota to receive allotments of goods and supplies from the U.S. government. The primary means of travel at the time was by water as there were no roads.

"On one of the trips for goods and supplies a party of Chippewa got into a fight with some Sioux at Fort Snelling and killed several. As the party of Chippewa passed the present site of Pepin, Wisconsin they saw a group of Sioux at Pepin and hollared and shook the scalps of the people that they had killed at the Sioux on the shore.

"The Sioux naturally took offense at this behavior, gathered a group of warriors and cut across country to the Chippewa River. This was likely with the aid of horses. The Chippewa were at a disadvantage because they had to go downstream to the mouth of the Chippewa River and then paddle upstream against the current of the Chippewa River.

"The Sioux caught up to the Chippewa at what is now known as Battle Island and killed the entire party except for an old woman and a baby. My recollection (which may be incorrect) is that 22 Chippewa were killed. The old woman and baby survived by playing dead and hiding.

"After the Sioux left, the old woman walked to Eau Claire were she died shortly after arriving. The baby was adopted by owners of the Murray Lumber Company in the Shaw Town portion of Eau Claire. The child eventually made her way to the Lac Courte Oreilles Reservation. Some years later, as an adult, she returned from the hospital after having a baby to find her husband in bed with someone else. She left with her baby and the clothes on her back and returned to Pepin where she eventually married John Weitz, father to Chauncey and grandfather to Dave."


